GROOMING, BOARDING & DAYCARE AGREEMENT**

I \_\_\_\_\_ hereby certify that my pet(s) are in good health, have not been ill with any condition in the last 30 days, and are up to date with all vaccinations and shots. I further certify that my pet(s) have not harmed or shown aggressive or threatening behavior towards any person or animal. I have read, understand and agree to the following:

I understand and agree that I am solely responsible and liable for any harm, injury or any other damage caused by my pet(s) while in the care of All Creatures Pet Grooming LLC ("Company"). I understand, agree and accept that there are risks involved when animals are in pack settings, and I agree to assume all risks and liability associated with such activities and my pet(s) participation therein, including but not limited to animal bites, diseases, and property damage caused to or from my pet(s). In the event my pet(s) cause damage to property or to another animal, I agree to be solely responsible and compensate the Company within three (3) days of receipt of written demand from the Company. I hereby agree to indemnify, defend and hold harmless the Company from any all claims by third-parties as to any claim or damage caused by my pet(s).

I understand and agree that the Company shall exercise due diligence and care in providing its services of pet grooming, boarding, and daycare ("Services"). However, the Company shall bear no responsibility or liability for loss, injury, or damage caused by or from disease, theft, fire, or harm from others pet(s) or property. I further agree to indemnify and defend the Company, its employees, members, directors, officers, volunteers, agents and representatives, and hold them harmless from any and all claims arising under or relating to my pet(s) participation in the Services. I understand and agree that any problems which develops with my pet(s) will be treated as deemed best by the Company at their sole discretion, and that I assume full financial responsibility for any and all expenses incurred, including but not limited to veterinary expenses.

Your pet(s) comfort and well-being is the Company's number one priority. With gentle and careful grooming, we look forward to making your pet(s) experience a favorable one. Although every effort is made to ensure that your pet(s) is groomed as safely as possible, working with animals can be unpredictable and accidents may occur. By signing this Agreement, you acknowledge that you have received and been explained our grooming policies and procedures. The Company will not be held responsible for irritations, minor nicks or skin rashes resulting from grooming pets with a matted coat, skin allergies or the clients request for a 'close cut'. Please note that when a pet is matted or has pre-existing skin ailment, the skin can become unhealthy and sore. Therefore it's difficult to groom a matted pet without irritating the skin. Shaving/stripping pets will dramatically change the pets appearance and the hair will be very close to the skin. This may expose pre-existing skin complaints.

Fees are based on daily rates. Aggressive dogs will be removed from day camp and isolated. A pet picked up late is subject to a late fee \$1 per minute starting 15 minutes after close; after which overnight boarding at owners' expense may occur beginning at 6:15 p.m. I hereby certify that my dog is up to date on Rabies, Bordetella and Distemper / my cat is up to date for Rabies and FVRCP. All pets will be checked for fleas and ticks upon arrival. Pets with fleas and/or ticks will receive treatment and a bath at the owner's expense without notice. Aggressive cats and dogs require special attention for boarding. We do accept aggressive pets; however, if your pet(s) shows aggression and we are unable to help them adapt to our environment, then an additional fee will apply for the one-on-one attention required.
